CASH WIRE TRANSFER OR PUBLICLY TRADED SECURITIES

You can find instructions and transfer details on our attached Gifts of Cash and Stock Form. Please provide the amount and anticipated transfer date to your relationship manager ahead of your transfer. In order to ensure delivery by December 31, we recommend initiating your gift no later than December 15. MUTUAL FUNDS

To receive transfer instructions or learn more, please call 303.300.1790 and ask to speak to a member of the Engaged Philanthropy Group. Please note that these transfers may take several weeks to complete. To ensure a successful transfer by December 31, please initiate mutual fund transfers by November 15.

This fall, we introduced *TDF Fund Manager*, a new online portal for fundholders that you can use to recommend grants as well as review fund balances and make gifts.

Once you log into your home page, you will be able to navigate seamlessly between views. An overview of available services includes:

Recommend a Grant: Multiple options to initiate a grant recommendation online, including a search tool. Drop-down lists of past grant recipients and funds make it easy to make recurring grants and/or transfer funds. Funds and initiatives of The Denver Foundation are highlighted.

Home Tab: An overview of current fund balance, recent contributions and grants, and a list of fund advisors.

Contribution History: Includes all gifts made to your fund, including contact information to acknowledge a third party for making a gift to your fund.

Grant History: Listings of total grants by recipient organization and individual grant transactions. You can also track the status of recommended grants.

In order to have your grants mailed before the end of the year, please submit your recommendations no later than December 23.

DECEMBER 24

Any grants recommended between December 24 and January 1 will be mailed the week of January 3-7, 2022.

DECEMBER 31

Donations by check must be postmarked by December 31.
